PAYMENT OPTION 1



EARLY SETTLEMENT

- ✓ An enrolment fee of R15,000 is required and must be paid by 30 November 2026. This amount will be credited toward the total course fee.
- ✓ Full settlement of all accommodation and tuition fees on or before registration day in 2027 will qualify for a R5,000 discount on the outstanding balance.

PAYMENT OPTION 2



DUAL PAYMENT

- ✓ An enrolment fee of R15,000 must be paid by 30 November 2026.
- ✓ A registration fee of R15,000 is payable on registration day in 2027.
- ✓ Both fees will be credited toward the total course fee.
- ✓ The remaining balance for accommodation and tuition fees will be divided into two payments:
 - First payment: **28 February 2027**
 - Second payment: **30 June 2027**
- ✓ This payment plan qualifies for a R3,000 discount, which will be applied to the second payment.

PAYMENT OPTION 3



DEBIT ORDER / MONTHLY PAYMENT

- ✓ An enrolment fee of R15,000 must be paid by 30 November 2026.
- ✓ A registration fee of R15,000 is payable on registration day in 2027. Both amounts will be credited toward the total course fee.
- ✓ The remaining balance for accommodation and tuition fees will be payable in nine (9) monthly instalments, from February to October 2027, due at the end of each month.
- ✓ A penalty fee of R200 will be charged for any failed debit order.
